<p>Rights (of the interested persons)</p>	<p>You can exercise your rights of access, rectification, deletion, limitation, opposition and portability at the indicated email address.</p>	<p><b>What are your rights when you provide us with your data?</b></p> <p>In the terms and with the scope established in the current regulations, any person has the right to:</p> <ul style="list-style-type: none"> <li>- confirm whether group ARAMARK is treating personal data that concerns you, or not, to access them and the information related to their treatment.</li> <li>- request the rectification of inaccurate data.</li> <li>- Request the deletion of the data when, among other reasons, they are no longer necessary for the purposes for which they were collected, in which case group ARAMARK will stop processing the data except for the exercise or defense of possible claims.</li> <li>- request the limitation of the processing of your data, in which case they may only be processed with your consent, with the exception of its conservation and use for the exercise or defense of claims or with a view to protecting the rights of another natural person or legal or for reasons of important public interest of the European Union or a certain Member State.</li> <li>- oppose the processing of your data, in which case group ARAMARK will stop processing the data, except for the defense of possible claims.</li> <li>- receive in a structured, commonly used and machine-readable format, the personal data that concern you and that you have provided to group ARAMARK, or request group ARAMARK to transmit them directly to another person in charge when technically possible.</li> <li>- withdraw the consent granted, where appropriate, for the purpose included in the section "For what purpose do we process your personal data?", without affecting the legality of the treatment based on the consent prior to its withdrawal.</li> </ul> <p>The above rights of access, rectification, deletion, limitation, opposition and portability can be exercised directly by the owner of the data or through a legal or voluntary representative through written communication addressed to the Legal Department, street Aribau 195 5ª planta, 08021 BARCELONA or either to the following email address:  <a href="mailto:protecciondedatos@aramark.es">protecciondedatos@aramark.es</a></p> <p>The interested party can file a claim with the Spanish Data Protection Agency, especially when he considers that he has not obtained satisfaction in the exercise of his rights, through the website enabled for this purpose by the corresponding Control Authority.</p>
